NOTICE:

Notice is hereby given for a Public Hearing to be heard by the Butte County Board of Education concerning the **Modification of Extended School Year Services**.

PURPOSE:

We will be requesting a General Waiver from the California Department of Education requesting a change in the number and length of days an Extended School Year (ESY) program is offered.

Background:

Butte County Office of Education (BCOE) proposes to provide Extended School Year (ESY) services to identified students with special needs, utilizing a fifteen (15) day, five and one half (5.5) hours/day instructional model, rather than the traditional model of twenty (20) days, four (4) hours/day of instructional time.

Students would receive the same or greater number of instructional minutes. The longer school day for ESY will align better with the regular school year providing more consistency for the students served. Additionally, the operation of ESY for 15 days instead of 20 will better match the district calendars of sites where BCOE classes are located allowing students more opportunities to be with their typically developing peers.

Financial Impact:

Fewer ESY days will result in substantial savings in transportation, utilities, janitorial, food services, administration and clerical costs.
